2 Saugus students struck by vehicle

Both were transported to the hospital after sustaining serious injuries

Two Saugus High School students were reportedly struck by a vehicle near their school on Monday, resulting in both being rushed to the to officials at the Los hospital.

The call for the collision was first reported at Alamogordo Road and Bouquet Canyon Road at approximately 8:55 a.m. Monday, according

Angeles County Fire Department.

"It was a traffic collision with two pedestrians involved," said Los Angeles County Fire

Low temps spark freeze alert

Road, weather conditions could lead to closures on the Grapevine

¬ollowing a rainy Christmas holiday in the Santa Clarita Valley, temperatures are set to remain low through the week, with a freeze watch warning issued for the greater SCV, while

snowfall may occur in the Grapevine, according to officials at the National Weather Service. The freeze watch alert was issued for the SCV Monday through Tuesday morning, with temperatures expected to drop between 28 and 32 degrees. Additional-

ly, temperatures are expected to remain below 50 degrees until The NWS expected 1 or 2 inch-

es of snow along Interstate 5 over the Tejon Pass through the night Monday into Tuesday. As a result, potential icy road conditions may last until Tuesday morning, resulting in travel delays and road

If snowfall impacts Interstate 5, then the California Highway Patrol and Caltrans may implement Operation Snowflake.

Operation Snowflake creates closures on the Grapevine and other mountain roads along Interstate 5. Decisions are based on road and weather conditions.

CHP offices in Tejon, Newhall and Bakersfield will work simultaneously to close down their roads to prevent serious traffic collisions, according to Officer Josh Greengard, a spokesman for the CHP Newhall-area Office.

Greengard said his agency is prepared and ready for the

weather conditions but must confirm heavy snowfall in the Tejon pass before implementing Operation Snowflake.

National Weather Service meteorologist Mike Wofford said a weather system is coming and is creating rain starting Monday afternoon into the evening, producing 3 to 7 inches of snow in the mountains.

"We could get some snow in the Grapevine around 4,000 feet," Wofford said. "It should all be gone by midnight (Monday) and be dry (Tuesday)."

L.A. County Public Health Department officials suggest residents in affected areas dress warm, limit time outside, bring pets indoors and check on elderly friends, family and neighbors.

COVID-19 testing demand **increase**

L.A. County has extended hours at testing sites, added weekday and weekend testing dates

Following a holiday weekend, long lines could be seen at COVID-19 testing centers across the Santa Clarita Valley Monday.

"We are seeing a dramatic increase in demand for COVID-19 testing at the Henry Mayo Newhall Urgent Care Clinic, as are urgent care clinics and other testing sites throughout the Santa Clarita Valley," said Larry Kidd, senior vice president and chief clinical officer at Henry Mayo.

Similarly, Exer Urgent Care's Chief Medical Officer Dr. Cory Spurlock said they, too, have been experiencing an end-of-year surge in COVID-19 cases and an overall increase in testing demands, especially during the holiday season.

"Exer Urgent Care is well-equipped to meet this increase in demand, as we've spent the past 20plus months of the pandemic adapting our services to swiftly respond to the community's need for pandemic-related care," Spurlock said.

Los Angeles County Department of Health Ser-

vices officials also announced last week they'd be expanding COVID-19 testing capacity to meet the holiday surge demand.

"L.A. County residents are doing right by getting tested as a precaution before gathering, if they have been exposed and at the first sign of symptoms," Dr. Christina Ghaly, director of Health Services, said in a prepared statement. "Getting tested and isolating as needed plays a vital role in our collective fight against the current holiday surge. We encourage anyone - including those who are vaccinated — to get tested if they believe they have been exposed or are experiencing symptoms. We will continue to closely monitor testing needs and

Holiday spending expected to soar

Projections estimate retail spending will reach \$860 billion this season

Holiday shopping is expected to break records, and projections estimate holiday retail spending reaching \$860 billion. Still, holiday returns average 13.3% of all holiday sales, which equals over \$100 billion in returns, according to the National Retail Federation.

Research conducted by NRF said more than 80% of holiday returns occur in January, with

3.23% making returns in December. However, even with increased returns, retail stores don't plan to hire more staff and expect more time needed to process those returns.

Additionally, year, many consumers made their purchases earlier than usual and may increase earlier instore returns.

For Kirk Yeager, owner of Paper Hero's Comics in Saugus, the business saw an uptick in sales during the last days

before Christmas, with many coming to the store the day after Christmas to spend the money they received as a gift.

Like many shoppers, Drake Rezendes was one of those customers who began their holiday shopping earlier this year but enjoyed supporting the small hobby shop.

"Well I got some cash from some people that didn't know what I wanted," Rezendes said. "So I came to Paper Hero's Comics because I'm invested in every hobby known to man.'

The last-minute purchases for Christmas saw the comic shop experience at least a 20% increase in holiday sales from last year, according to Yeager.

Returns at the comic shop are nearly nonexistent because the items sold at Paper Hero's Comics are not returnable. However, people have offered to sell collectors' items such as Pokemon or Yugioh

Students build, operate Legos

West Ranch hosts Lego League Championship; more than 400 compete

Ranch High West School with Project 691 First Robotics team hosted the Southern California First LEGO League Championship on Sunday.

The championship featured more than 400 elementary and middle school students from Southern showcasing California, their work from the previous semester in building robots to complete various missions and completing a research project to improve transportation of goods.

Teams in Southern California competed in 19 different qualifying tournaments, and this year the championship was held at West Ranch. In previous years, West Ranch has hosted qualifying tournaments, but this is the first time the school hosted the championship.

The theme and challenge for the tournament were cargo connect, reimagining and innovating ways to improve global transportation. After two years of competition being held remotely because of CO-VID-19 disruptions, the championship returned in person.

The event had a hybrid model allowing 40 teams to attend in person and 10 teams competing remotely. The remote teams had judges and referees sitting on computers and working through Zoom.

is to foster science, technology, engineering and math in children with an international robotics program. Students engage in hands-on STEM experiences, building confidence, growing their knowledge and developing habits of learning, according to the FIRST League website.

"They are looking at ways to improve transportation of cargo and they also get judged on their core values and in robot design," program delivery partner Paul Kass said. "They're looking at how they built the robot and programming."

Kass said, regardless of the obstacles faced with COVID-19, he's glad to

provide this competition for the students and families. Additionally, Kass is glad children can compete in person and interact with volunteers, judges and referees.

"The kids are having a great time and it's wonderful to see their smiling faces, to hear their cheering

and laughter," Kass said.

Aaron Dolgin, mentor of team Project 691 and tournament director of Southern California FLL Championship, was a member of the robotics team while a West Ranch student and has become a mentor for the program in Santa

He said many of the students are happy to get out of the house and experience this return to normalcy and interact with others.

Team Project 691 is comprised of 40 students from throughout the William S. Hart Union High School District. The team volunteered their time along with 60 other volunteers from around the Los Angeles region, according to Dolgin.

Dolgin thanked West Ranch High School for allowing the championship to be hosted on campus and providing team Project 691 a facility to build their designs for the robot-

"This is what we call our home base," Dolgin added. "West Ranch has been very welcoming and easy to work with."

Danielle Hedvig, a volunteer for the event and a second-year team member of Project 691, works on programming and design. She programs the functions to get robots to complete tasks.

Additionally, volunteer Jathin Korrapati is a fourthyear member of the robotics team who helps with computer-assisted design.

Team Project 691 competes in a competitive division, but Korrapati and Hedvig both enjoyed volunteering for the event because it allows them to pay it forward; additionally, it's rewarding to impact the younger students interested in STEM, according to Korrapati.

Hedvig is amazed to see the young students competing and is excited to cultivate science in the younger student community.

"It's super rewarding because I was in their spot a few years ago," Hedvig said. "Eventually, they're going to be competing and doing what we're doing

Department representative Geovanni Sanchez. "Both were transported to the nearest hospital."

"Two students with the Saugus cross-country team were struck by a vehicle," said Dep-uty Natalie Arriaga, a spokeswoman for the Santa Clarita Valley Sheriff's Station. "The investigation remains ongoing."

Dave Caldwell, spokesman for the William S. Hart Union High School District,

confirmed Monday that the district had been made aware of the incident and officials were notified that both students were receiving medical care.

The woman was driving the vehicle stopped after the collision and remained on the scene to speak with investigators.

Jim Scott, a witness to the incident, who assisted the boys following the crash, said he was waiting at the Alamogordo/Bouquet Canyon intersection light when the crash occurred Monday

morning. He described

both runners as having sustained serious iniuries: one boy's head collided with the windshield while the other suffered a major injury to his leg, he said.

When asked if the car had run a red light, or what had transpired to lead to the crash, Scott said he did not know due to the traffic-actuated lights.

"(The runners) got to waiting for their turn there, and so I came up to a stop, and they started running across the crosswalk," said Scott. "So, they cross the two lanes going southbound

and the median and that's when the car came up on the inside lane and struck two of them."

"I can't say what it looked like from their side," Scott added, in reference to the driver's viewpoint.

No arrests as a result of the investigation have been made as of the publication of this article, Arriaga added.

"That requires an investigation," said Arriaga, when asked if investigators believed the driver had been at fault. "We do have to study all diameters in order to determine a cause."

Deputies suspect alcohol involved in Christmas crash

Law enforcement officials said they believe drunk driving resulted in a Christmas Day crash, with the driver allegedly testing two times over the legal limit.

It is illegal to drive in the state of California with a blood alcohol content of 0.08% or more.

L.A. County Public Health Department officials have issued a cold weather alert and suggest residents in affected areas dress warm, limit time outside, bring pets indoors and check on elderly friends, family and neighbors.

"Children, the elderly, and people with disabilities or special medical needs are especially vulnerable during cold weather. Extra precaution should be taken to ensure they don't get too cold when they are outside," L.A. County Health Officer Muntu Davis said. "There are places where people can go to stay warm, such as shelters or other public facilities. We also want to remind people not to use stoves, barbeques or ovens to heat their homes due to the risk of carbon monoxide poisoning.'

Prolonged exposure to the cold could lead to hypothermia, while extreme

cold could lead to frostbite. Public Health advises those who show signs of either to seek immediate medical care.

Amazon truck catches fire

Officers: Driver was uninjured

An Amazon truck that caught fire resulted in a SigAlert for truck lanes in the Newhall Pass Monday afternoon.

The incident was reported around 4:15 p.m. when the cab of an 18-wheeler big rig was reportedly on fire on the right shoulder of the northbound Interstate 5 to Highway 14 truck lanes, according to California Highway Patrol Officer Edgar Figueroa.

CHP officers arriving on the scene discovered the cab of the big rig engulfed in flames, Figueroa said.

While the driver was reportedly not injured in the incident, a SigAlert was issued for the truck lanes for around one hour as first responders worked to clear the scene, Figueroa added.

cards that may have stolen from a major department store or an individual, according to Yeager.

Additionally, people have tried to sell products to comic shops that are fake productions of high-valued cards from China.

"So they're making fakes and flooding the market with expensive cards on occasion," Yeager said.

Total returns account for \$428 billion in lost sales for retailers, and online sales account for the overall increase in returns. Additionally, for every \$100 of returned merchandise, a retailer will lose \$5.90, according to NRF.

Fraudulent returns average 10.1% of all holiday returns or equal \$10 billion in lost revenue. However, returns offer a unique opportunity for retailers to build a relationship with their customers.

Returns after Christmas creates a unique opportunity for retailers to engage their customers and learn from their buying habits. Nearly 70% of

customers prefer to return items — in-store — even if purchased online.

The ability to return an item purchased online or from a holiday gift can encourage buyers to purchase more merchandise, according to NRF.

In a survey conducted by NRF, more than 65% of people surveyed said they plan to do post-Christmas shopping. The three biggest reasons include purchasing items with special offers, using gift cards and exchanging or returning gifted items.

Bobby Hernandez and Brittany Barrera visited the Westfield Valencia Town Center to return some gifted items to Forever 21 because some merchandise was the wrong size. They're like many Americans shopping and returning items after Christmas.

Barrera said chose to go shopping on the day after Christmas to find the right size for her exchange and found additional merchandise she wanted to buy that matched her needs and didn't want to risk not finding the right size later.



Enrollment Declines Squeeze Finances

The 1970s and 1980s were a tumultuous time for California's public schools, to wit:

— A tidal wave of kids from the post-World War II baby boom pushed school enrollment to well over 4 million, but the end of the boom in the mid-1960s and a slowdown in overall population growth drove enrollment downward in the 1970s. Throughout the state, local school systems pared back school construction, sold off school sites and even closed some schools.

— At the time, schools were largely financed by locally imposed property taxes, but in 1971 a successful lawsuit, Serrano vs. Priest, declared that widely varying taxable property values among the state's school districts unfairly disadvantaged children in lowwealth communities. In response, the Legislature began overhauling school finances to provide what was called "equalization."

— Subsequently, however, in 1978, voters passed Proposition 13, which clamped tight limits on property taxes, compelling the state to assume the fundamental task of financing schools from income and sales taxes and thus shifting wrangling over education finance to the state Capitol.

— California's population soared in the 1980s due to high immigration and birth rates and so did school enrollment, eventually topping 6 million. In 1988, a decade after Proposition 13's approval, the education community persuaded voters to pass Dan WALTERS

Proposition 98, an extremely complex measure that dictates how schools' share of state revenues is calculated. It has dominated the state budget process ever since.

This snippet of political history is offered because it could be repeated.

California's once-soaring population has slowed to a trickle, or perhaps even reversed, due to sharp declines in immigration and birth rates. Also, school enrollment, which topped out at 6.2 million a decade ago and remained virtually unchanged until recently, is beginning what demographers believe will be a steady decline.

The COVID-19 pandemic is partially responsible for some recent declines but the state Department of Finance projects that underlying demographic trends will drop enrollment to 5.5 million by 2030, some 700,000 lower than the peak.

"Projected declines are greatest in Los Angeles and Ventura counties — roughly 20% lower by 2030–31," a recent study by the Public Policy Institute of California declares. "The declines in Los Angeles County are particularly noteworthy: county enrollment has already fallen over 10% in the past decade, and enrollment in 2030–31 is projected to be 30% lower than it was in 2010–11."

State aid to schools is largely driven by enrollment, so districts that are seeing major declines, particularly large urban systems such as Los Angeles Unified, are beginning to feel the financial pinch and confronting the unpopular task of shutting neighborhood

At the moment, school finances have a respite. Gov. Gavin Newsom and legislators have decreed that state aid is temporarily based on pre-pandemic enrollment but the "hold harmless" gesture is due to expire next year. What happens after that is anyone's guess.

Decreasing enrollment could be beneficial in the long run, because it could increase per-pupil spending. But that would depend on the willingness of state politicians to once again change the methodology of school financing, moving away from its enrollment base to some other model.

Given the tens of billions of dollars at stake, however, a major overhaul would be a tough political slog. Until and unless it occurs, the local systems seeing the most dramatic enrollment declines will have a difficult time balancing their budgets as their state aid shrinks and their fixed costs, such as pension fund contributions, continue to rise.

new dwellings are being built. Yes, that's true. We're in a drought period and water supplies are running low. Yes, that's also true. But...and this is a BIG but...that's not how urban development planners decide things. Mr. Perry cited some pretty impressive sources, ranging from the U.S. Geological Survey to NASA, but that's only half the picture. I did not see a single water utility in his list of sources. He didn't use the Metropolitan Water District or even SCV Water as a source for information that, if he had it, would have made what he said in his letter "completely" correct, which it isn't. In fact, he probably wouldn't have written it in the first place.

have written it in the first place. For example, the Los Angeles Department of Water and Power, where I work (and on the water side, no less), updates its Urban Water Management Plan every five years and that 280-page report projects water supply and use looking ahead 25 years. That report is approved by the LADWP Board of Commissioners, certified by the L.A. City Council, and submitted to the state Department of Water Resources. Every water utility in the state with more than 3,000 customers is required by state law to do this. So to make a very long story very short, the water that will be used by these new residences was already allocated several years ago, droughts notwithstanding. The Urban Water Management Plans take into consideration a variety of factors, only half of which are

covered by Mr. Perry's sources.

I would suggest Googling the "Urban Water Management Plan" for "SCV Water" for the longer version of what I just wrote.

Omicron variant spreads faster than previous mutations

Dear Doctors: Can you please talk about the Omicron variant? I keep hearing different information about whether it's worse than the Delta variant and how sick it's going to make you. Why has there been so much panic about this new variant?

Dear Reader: We're hearing from many readers regarding the Omicron variant of SARS-CoV-2, which is the coronavirus that causes COVID-19. We're happy to address what is known thus far, and fully expect to be writing updates as research and data reveal

more. Omicron was first reported to the World Organization Health from South Africa in late November. Its appearance coincided with a marked surge of new infections in the region, which put researchers on high alert. Testing showed that this new variant was spreading faster than previous forms of the coronavirus. When analysis of the virus revealed a significantly higher number of mutations than have previously been observed, Omicron was classified as a "variant of concern." One month after it was identified, the variant was confirmed to have spread to 38 countries on



six continents. The surprisingly rapid spread of a new variant, along with the dozens of mutations that it exhibits, have likely helped drive public concern.

As we've discussed here before, the job of a virus is to replicate. In the course of making multiple copies of itself, genetic mistakes occur. Most of the time, these errors have no effect on the virus and are not repeated. But sometimes, the genetic changes that occur during replication help the virus to become more successful. The end result is that particular version of the virus will get replicated more often, which gives rise to what is known as a variant. That's the mechanism that resulted in the Delta variant, and it is now in play with the Omicron variant.

What remains be seen is what Omicron's changes to the viral structure of SARS-CoV-2 mean to those who become infected with the virus. It appears that the Omicron variant spreads faster than it's too soon to know for sure. Also unclear at this time is whether Omicron is more severe than other variants. Thus far, COVID vaccines continue to protect against severe disease and death. However, as with the Delta variant and original coronavirus, breakthrough infections are expected. Unfortunately, it will take more realworld data to learn more about how the Omicron variant behaves.

What remains certain is that you can lower your risk of infection through the vigilant use of high-quality masks. While the virus particles themselves are microscopic, they can't move on their own. They hitch a ride on the droplets of a cough, sneeze or exhalation, and those can be physically stopped by the fabric of a good mask. N95 masks, which offer the highest protection, are once again widely available. If you haven't yet been vaccinated, we urge you to do so. And if you're six months or more beyond the second dose of a two-dose vaccine, or two months beyond the Johnson & Johnson vaccine, it's important to get a booster.

Dear Doctors: Is it true that we're being told to eat even less salt than

the Delta variant, but before? I've been hearing that there are new rules about that, but I don't know what they are. How much salt is OK to eat? Why is it that this kind of advice keeps changing?

> Dear Reader: You are correct about the recent release of updated guidance regarding how much salt we should — or, more accurately, should not — be eating. And it's not a surprise that you're feeling a bit confused. Federal nutrition advice for individuals comes in the form of the Dietary Guidelines for Americans, which are jointly issued by the United States Department of Agriculture and the Department of Health and Human Services.

> However, the new information about salt that you're asking about comes from a different source, namely the Food and Drug Administration. It's aimed not at individuals, but, rather, at the food industry. And because compliance is voluntary — it's basically a request — it has been labeled as "guidance." Specifically, the FDA is asking food manufacturers, restaurants and other vendors of prepared foods to cut the amount of salt in their products in order to help reduce the amount of salt

that the average American consumes each day.

Over the next 30 months, the FDA wants the food industry to adjust its products so that sodium intake drops from 3,400 milligrams to 3,000 mg per day. Despite this being about 12% lower than current sodium levels in prepared foods, it's still markedly higher than the 2,300 mg of sodium per day in the official Dietary Guidelines. And that's the point. Due in large part to the prevalence of prepared foods in the American diet, the average adult here consumes 3,400 mg of sodium per day — and often more.

A study that looked at 450 adults from geographically diverse areas in the U.S. found that salt added to food eaten outside of the home accounted for a whopping 70% of each person's daily sodium intake.

The adverse health effects of excess salt in the diet are well-known. It can lead to high blood pressure, which increases the risk of stroke, heart attack and heart disease. As a reminder, the Dietary Guidelines recommend children between 1 and 3 years old consume less than 1,200 mg of sodium per day. Children between the ages of 4 and 8 should consume less than 1,500 mg per day, and those 9 to 13 years old should get less than 1,800 mg of sodium per day. And, as we mentioned earlier, 2,300 mg of salt per day is the recommended limit for those 14 years old and older.

Whether or not food manufacturers will comply with the FDA's request remains to be seen. But understanding how much sodium is added to prepared food before you even touch a salt shaker can help you limit your own intake. People who make it a practice to read sodium percentages on food labels say they're often startled by the high numbers, and that this awareness lets them make healthier choices for themselves and for their families.

adjust capacity as needed in the coming weeks."

L.A. County capacity expansion includes extended hours of operation at sites across the county, additional weekday and weekend testing dates, additional mobile testing units in hard-hit areas, and the relaunching of the holiday home test collection program with new guidelines to reach more people and make it easier to get tested.

Any L.A. County resident who is symptomatic or believes they were exposed to COVID-19 can order a home testing kit, which requires swab collection to be mailed back for a PCR test result.

As more and more people get tested, L.A. County has continued to see a surge in case rates, with 7,425 cases reported on Monday, according to the county Department of Public Health.

Henry Mayo also reported four additional deaths related to COV-ID-19 Sunday, for a total of 195 since the onset of the pandemic, according to hospital spokesman

Patrick Moody. Meanwhile, the U.S. Centers for Disease Control and Prevention on Monday announced it had shortened the isolation times for those who have tested positive for

COVID-19 from 10 days to five days if asymptomatic, if they wear a mask around others for at least five more days.

The CDC also shortened the recommended time for people to quarantine if exposed to CO-VID-19 to five days if they are vaccinated, while those who are fully vaccinated and boosted may not need to quarantine at all.

Public Health continues to remind residents that getting vaccinated or boosted remains critical as holiday traveling and gatherings continue, as well as getting tested and wearing masks.

The change is motivated by science demonstrating that the majority of COVID-19 transmission occurs early in the course of illness, generally in the one to two days prior to onset of symptoms and the two to three days after, per the

society," CDC Director Dr. Rochelle Walensky said in a prepared statement. "CDC's updated recommendations isolation and quarantine balance what we know about the spread of the virus and the protection provided by vaccination and booster doses. Prevention is our best option: get vaccinated, get boosted, wear a mask in public indoor settings in areas of substantial and high community transmission, and take a test before you

gather." L.A. County Public Health officials have yet to clarify whether they'd modify the county's health officer order to align with the CDC's new guidance.



At the bridge table, often the hardest part is actually thinking of the right bid or play. It does not sound like such a Herculean task because the number of choices is limited, but many players do not train themselves to analyze the ontions

In today's deal, what are the best plays by each side in three no-trump after West leads the heart queen?


South sees seven top tricks: one spade, two hearts, two diamonds and two clubs. He will get one more trick from spades if he finds a lucky 3-3 break. However, that would still leave declarer a trick shy of his contract. Aiming to get four club tricks is much more sensible. But how do you think he should do that?

An unthinking player would cash the king and follow with a finesse of dummy's jack. That will work fine if the missing clubs are 3-2. However, when

West turns up with four clubs including the queen, this doesn't work so well. Much better is to cash the club king, then to duck the second round. Here, South sees East discard, so he knows to play low to dummy's jack on the third round of the suit.

Before moving to the comics, though, did you think of West's clever play? When South leads his second club after cashing the king, West should play his queen! South is bound to win with dummy's ace and, here, go down.

Even if a clever South first leads a low club from his hand, West can still play the queen.
